Archer Hog Oil with Lindane being low-freezing, remains quite thin in very cold weather, therefore it is excellent for use in Hog Oilers.

An effective hog oiler or rubbing post can be made by setting a post firmly in the ground and wrapping it securely with gunny sack or rope that is kept saturated with oil. Pour oil over the post covering from time to time, or a can of oil may be fastened to the top of the post and the rope or gunny sack kept saturated by fastening the upper end in the vessel of oil.

The use of Archer Hog Oil with Lindane is limited to use in Hog Oilers only; one of the principal active ingredients being oil, Archer Hog Oil, with regard to considerations of safety or residues, should not be applied by sprinkling cans, a mop or brush.

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

1. Add the following protective clothing statements to the label:

~~Applicators must wear lightweight protective suits or coveralls, unlined waterproof gloves and unlined lightweight boots.~~

2. The labeling should be brought into conformance with current requirements as to required text, headings, and type size. Refer to the enclosure and modify the label accordingly.
3. Add a storage and disposal section to the label. Refer to PR Notices 83-3 and 84-1 for guidance.
4. A Statement of Practical Treatment must be added to the labeling. We suggest the following statement; however, if your toxicological data suggest otherwise, please submit a draft Statement of Practical Treatment for prior approval:

If swallowed - Call a physician or Poison Control Center immediately. DO NOT INDUCE VOMITING. Vomiting may cause aspiration pneumonia.

If inhaled - Remove victim to fresh air. Apply artificial respiration if indicated.

If on skin - Remove contaminated clothing and wash affected areas with soap and water.

If in eyes - Flush eyes with plenty of water. Call a physician immediately.

- 5. Add the statement "It is a violation of Federal law to use this product in a manner inconsistent with its labeling" to the beginning of the use directions, just after the heading "Directions for Use."
- 6. Delete "CAUTION" from the label as it conflicts with the signal word.
- 7. "KEEP OUT OF REACH OF CHILDREN" must appear just above the signal word.
- 8. Delete "Wash immediately with soap and water, in case of contact" and substitute "Wash thoroughly with soap and water after handling and before eating or smoking."
- 9. Submit an updated Confidential Statement of Formula for the product, as the Agency has no formula on file. Include the flash point; depending upon the flash point, certain chemical or physical hazards statements may be applicable.

Submit five (5) copies of your revised final printed labeling before you release the product for shipment with the amended labeling.

A stamped copy of the label is enclosed for your records.

If you hold a Federal registration, a supplemental registration, or a Special Local Needs registration, you may continue to produce new stocks of such products, using current labeling, until June 30, 1984. After that date, all remaining inventories of affected products will fall under the Existing Stocks provisions stated in our letter of October 28, 1983.
