STORAGE AND DISPOSAL:

PESTICIDE STORAGE: Store this product in a cool dry area, away from direct sunlight and heat to avoid deterioration. Do not contaminate food or feed by storage, disposal, or cleaning of equipment. In case of spill, flood areas with large quantities of water. Product or rinsates that cannot be used should be diluted with water before disposal in sanitary sewer.

PESTICIDE DISPOSAL: Pesticide wastes may be hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law. <u>CONTAINER CLEANING</u>: Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

<u>Triple Rinse</u>: If container has a capacity greater than five (5) gallons, triple rinse as follows: Empty remaining contents into application equipment or mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

If the container has a capacity of five (5) gallons or less, triple rinse as follows: Empty the remaining contents into application equipment or mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

<u>Pressure Rinse</u>: Pressure rinse as follows: Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

NOTE: This product degrades with age. Use a chlorine test kit and increase dosage, as necessary, to obtain the required level of available chlorine.

SWIMMING POOL WATER DISINFECTION

For an new pool or spring start-up, superchlorinate with 58 to 116oz. of product for each 10,000 gallons of water to yield 5 to 10 ppm available chlorine by weight. Check the level of available chlorine with a test kit. Adjust and maintain pool water pH to between 7.2 to 7.6. Adjust and maintain alkalinity of the pool to between 50 to 100ppm.

To maintain the pool, add manually or by a feeder device 14oz. of this product for each 10,000 gallons of water to yield

an available chlorine residual between 0.6 to 1.0 ppm by weight. Stabilized pools should maintain a residual of 1.0 to 1.5 ppm available chlorine. Test the pH, available chlorine residual and alkalinity of the water frequently with appropriate test kits. Frequency of water treatment will depend upon temperature and number of swimmers.

Every 7 days, or as necessary, superchlorinate the pool with 58 to 116oz. of product for each 10,000 gallons of water to yield 5 to 10 ppm available chlorine by weight. Check the level of available chlorine with a test kit. Do not reenter pool until the chlorine residual is between 1.0 to 3.0 ppm.

At the end of the swimming pool season or when water is to be drained from pool, chlorine must be allowed to dissipate from treated pool water before discharge. Do not chlorinate the pool within 24 hours prior to discharge. WINTERIZING POOLS - While water is still clear & clean, apply 5oz. of product per 1000 gallons, while filter is runi to obtain a 3 ppm available chlorine residual, as determined by a suitable test kit. Cover pool, prepare heater, filter and heater components for winter by following manufacturer's instructions.

<u>PUBLIC SYSTEMS</u>: Mix a ratio of 2.5oz. of this product to 100 gallons of water. Begin feeding this solution with a hypochlorinator until a free available chlorine residual of at least 0.2 ppm and no more then 0.6 ppm is attained throughout the distribution system. Check water frequently with a chlorine test kit. Bacteriological sampling must be conducted at a frequency not less than that prescribed by the National Primary Drinking Water Regulations. Contact your local Health Department for further details.

SEWAGE AND WASTEWATER EFFLUENT TREATMENT

The disinfection of sewage effluent must be evaluated by determining the total number of coliform bacteria and/or fecal coliform bacteria, as determined by the Most Probable Number (MPN) procedure, of the chlorinated effluent has been reduced to or below the maximum permitted by the contolling regulatory jurisdiction.

- On the average, satisfactory disinfection of secondary wastewater effluent can be obtained when the chlorine residual is 0.5 ppm after 15 minutes contact. Although the chlorine residual is the critical factor in disinfection, the importance of correlating chlorine residual with bacterial kill must be emphasized. The MPN of the effluent, which is directly related to the water quality standards requirements, should the final and primary standard and the chlorine residual should be considered an operating standard valid only to the extent verified by the colliform quality of the effluent. The following are critical factors affecting wastewater disinfection.
- 1. Mixing: It is imperative that the product and the wastewater be instantaneously and completely flash mixed to assure reaction with every chemically active soluable and particulate component of the wastewater.
- 2. Contacting: Upon flash mixing, the flow through the system must be maintained.
- 3. Dosage/Residual Control: Succesful disinfection is extremely dependent on response to fluctuating chlorine demand to maintain a predetermined, desirable chlorine level. Secondary effluent should contain 0.2 to 1.0 ppm chloring residual after a 15 to 30 minute contact time. A resonable average of residual chlorine is 0.5 ppm after 15 minutes contact Please contact your local JCI Jones Chemicals, Inc.office for additional directions for use.
