Remove all lower drawers in hitchen and bathroom cabinets, bedroom dressers and chests of drawers, then scatter liberally in drawer wells.

Reapply as necessary. Any powder visible after application must be brushed into cracks and crevices or removed. Apply only in areas inaccessible to children and pets. Avoid contamination of feed and foodstuffs.
