Nalkil Weed Killer 2412 Granular is a non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is recommended only for non-cropland areas such as railroad rights-of-way and industrial areas. 200 to 300 pound applications of Nalkil 2412 Granular per acre usually result in a non-productive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, soil type and other conditions.

ECTIONS. NalKil Week Killer 2412 Granular should be applied as furnished with a seed spreader, a fertilizers spreader, a shaker type applicator, or with any equipment which will distribute the chemical uniformly over the area to be treated. Application equipment is available from Naico. Apply 40 to 75 pounds per acre for control of Barnyardgrass, Bromegrass, Annual Bluegrass, Buckthorn Plantain, Cheatgrass, Crabgrass, Clovers, Fiddleneck, Foxtail, Lambsquarter, Pigweed, Puncture Vine, and Thistles. Apply 85 to 150 pounds per acre for control of Bindweed, Brambles, Docks, Milkweed and Quackgrass. Higher dosages or repeated spot treatment may be required when deep rooted perennial weeds are present. To obtain best results, NalKil 2412 Granular should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. NalKil 2412 Granular may, however, be applied at any time of the year. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season. Users should consult state agricultural experiment stations or extension service weed specialists for recommendations as to use in their particular area or write to Nalco.

IMPORTANT: Do not apply on or near valuable woody or herbaceous plants or in areas where their roots may extend, because of possible injury to such plants. Thoroughly clean spreading equipment with a suitable chemical cleaner before using for other purposes (or do not use same spreading equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Store away from and do not comtaminate feed and foodstuffs. Do not contaminate irrigation ditches or water used for domestic purposes. Do not use on croplands or any land to be used for subsequent cropping. Keep animals off treated areas. Do not re-use this container.

Avoid contact with skin, eyes, and clothing. Avoid breathing dust. Do not take internally.
