#### **DANGER**

FIRST AID

INDUSTRIAL RECIRCULATING WATER SYSTEMS: For control of bacteria and algae in industrial cooling towers and evaporative condensers, treat the system with 6.4 - 25.6 fluid ounces of WRICO BGA microbiocide per 1000 gallons of water in the system.

**INITIAL DOSE:** When the system is noticeably fouled, add 13.0 - 25.6 fluid ounces of WRICO BGA microbiocide per 1000 gallons of water in the system. Repeat until control is evident.

SUBSEQUENT DOSE: When microbial control is evident, add 6.4 - 12.8 fluid ounces of WRICO BGA microbiocide per 1000 gallons of water in the system as needed to maintain control.

WDUSTRIAL PROCESS WATER SYSTEMS: For control of bacteria in industrial process water systems, treat the system with 6.4 - 25.6 fluid ounces of WRICO BGA microbiocide per 1000 gallon of water in the system.
