### DIRECTIONS FOR USE

For treating 1000 square feet, under ordinary conditions, dilute 1 to 2 gallons of NS 610 with sufficient water to give good coverage. For application — use a sprayer that will produce a coarse wet spray and that will apply the solution evenly over the entire area. For best results treat shortly before or at the time plant growth begins. Adequate control is possible when the vegetation is short or just after mowing. Thorough watering 24 hours after application will move the material to the root zone and speed up control. The effectiveness and length of time that control will last will depend on type of soil, amount of rain and other conditions.
