To control annual weeds and grasses such as foxtail, ryegrass, wild oat, crabgrass, cheatgrass, ragweed, lambsquarters and turkey mullein, dilute one gallon of National Chemsearch FENOCIL III to 9 gallons of water and apply 5 gallons of the diluted spray per 1000 square feet.

For the following perennials such as smooth brome, Canada bluegrass, purpletop, quackgrass, broomsedge, aster dandelion, dog fennel, goldenrod, plantain and wild carrot, dilute one gallon of National Chemsearch FENOCIL III to 9 gallons of water and apply 10 gallons of the diluted spray per 1000 square feet.

For harder to kill perennial weeds and grasses such as johnsongrass, saltgrass, bouncing bet, bracken fern or horsetail, dilute 1 1/2 to 2 gallons of National Chemsearch FENOCIL III to 15 gallons of water and apply to 1000 square feet.

NOTE: Do not let the liquid come in contact with susceptible plants such as vegetables, flowers, fruit trees, ornamentals, cotton, grapes or other desirable plants or allow spray mist to drift onto these plants. (Coarse sprays are less likely to drift). Thoroughly clean spray equipment before using for other purposes. Do not store near fertilizers, seeds, insecticides or fungicides.
