DIRECTIONS

For treating 1000 square feet, under ordinary conditions, dilute 2 to 4 gallons of APTREX with sufficient water to give good coverage. For application, use a sprayer that will produce a coarse wet spray and that will apply the solution evenly over the entire area. For best results, treat shortly before or at the time plant growth begins. Adequate control is possible when the vegetation is short or just after mowing. Thorough watering 24 hours after application will move the material to the root zone and speed up control. The effectiveness of control and length of time that control will last will depend on type of soil, amount of rain and other conditions.

NOTE: Do not apply APTREX, allow it to drift, or drain or flush application equipment onto or near croplands, lawns, trees or other desirable plants or to areas where their roots may extend. DO NOT contaminate irrigation or domestic water supplies. DO NOT allow contact with fertilizers, insecticides, fungicides or seed. Application equipment should be thoroughly cleaned with a detergent and water to prevent corrosion. Equipment which has been used to apply this product should not be used for applying insecticides, fungicides, fertilizers or other agricultural chemicals, as plant injury may result.
