WARNING

Causes eye and skin irritation. Do not get in eyes, on skin or on clothes. Harmful if swallowed. Avoid contamination of food.

Skin: If contact does occur, wash skin thoroughly with soap and water. Wash contaminated clothing. If skin irritation occurs, contact a physician.

Eyes: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. See a physician.

Ingestion: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution; or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, as well as oxygen and measures to support breathing manually or mechanically may be needed. If persistent, convulsions may be controlled by the cautious intravenous injection of a short-acting barbiturate drug.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

Pesticide Disposal: Pesticide, spray mixture or rinsate that cannot be used or chem-

ically reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies.

Container Disposal: Triple rinse (or equivalent) and dispose in an incinerator or landfill approved for pesticide containers, or bury in a safe place.

General: Consult Federal, State or Local Disposal Authorities for approved alternate procedures such as limited open burning.

Fabric treated as directed will develop residual bacteriostatic activity against Gram positive (*S. aureus*) and Gram negative (*K. pneumoniae*) organisms, under conditions of high relative humidity or wet contamination.

HEAVEN-SOFT inhibits the growth of ammonia-producing organisms (*B. ammoniagenes*) which act on urine in the diapers to produce ammonia.

HEAVEN-SOFT softens clothes, thus eliminating chafing. Takes "Static Clings" out of nylons and other synthetics. Improves ironing time.

DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use 3 ounces HEAVEN-SOFT per 10 pounds of laundry in rinse cycle.
