NET CONTENTS

KLEARSOL 69 Wash and Surface Sanitizer is recommended for use on hard (non-porous) surfaces or on dishes, glasses, food processing equipment or ulensils including deiry and brewery equipment ulensils that need a strong sanitizer treatment with little or no cleaning action. This material is very effective on table tops, tanks, vats, floors and walls. It is also very effective on dishes, glasses, metallic ulensils and equipment.

#### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Dissolve 11% oz. KLEARSOL 69 Wash and Surface Sanitizer per 10

Dissolve 1% oz. KLEARSOL 69 Wash and Surface Sanitizer per 10 gallons of water to give a solution containing 200 ppm available chlorine. After cleaning to remove gross filth and heavy soil from surface, apply the sanitizing solution to the surface to be sanitized and let stand 2-5 minutes. Rinse well with potable water and dry. The surface is then ready for use.

The same solution may be used in the feed tanks in immersion or spray type machines providing 2-5 minutes contact time for sanitizing dishes, glasses, food processing equipment and utensits. Clean and rinse items prior to sanitizing. After sanitizing step, rinse well with potable water and dry. They are then ready for use.

The sanitizing solution should be used promptly after mixing. If the solution is allowed to stand or is reused and tests show the level of chlorine has not been maintained, additional KLEARSOL 69 Wash and Surface Sanitizer should be added to maintain a use solution at 200 pom available chlorine.

## STORAGE AND DISPOSAL

Keep product dry in tightly closed containers when not in use. Store in a cool well-ventilated area away from heat or open flame. In case of a decomposition isolate container if possible and flood with large amounts of water to dissolve all material before discarding. Place in trash collection or dispose in approved landfill area or bury in a safe place.
