Y POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: Headache, nausea, vomiting, cramps, weakness, blurred vision, pin-point pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma.

FIRST AND TREATMENT

Keep all unprotected persons and children away from Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition.

> immediately and maintain until doctor sees victim. to drink. Repeat until vomit is clear. Never give anything by mouth to an unconscious person. Have victim lie down and keep quiet. See doctor immediately.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while noving contaminated clothing and shoes. See docor immediately.

NOTE TO PHYSICIAN

Antidote—administer atropine sulfate in large doses, TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 10 min ute intervals until signs of atropinization appear. 2-PAM chloride is also antidotal and may be admin istered in conjunction with atropine. DO NOT GIVE MORPHINE OR TRANQUILIZERS. Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pulmonary edma, the patient should be given supplemental oxygen and treated symptomatically. Con tinued absorption of the poison may occur and fatal relapses have been reported after initial improvement; VERY CLOSE SUPERVISION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS
