Repeat applications as necessary. For more detailed information consult your State Experiment Station or Extension Service.

IN THE PLANT BED, apply to plants before the disease strikes, but in any event prior to the time when the plants reach 4-leaf stage at the rate of 1½ to 2 pounds per 100 square yards, increasing to 3½ pounds per 100 square yards when the plants are large or at the first sign of Tobacco Blue Mold. Repeat applications twice a week until the crop is transplanted to the field. Repeat applications following rain and be sure to give uniform and thorough coverage.
