Directions for Use:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Directed Postemergence Application

Apply as a directed spray, adjust nozzles to minimize contact to cotton leaves with spray or drift as crop injury may result. Do not spray over top of cotton. Make first application of 1 pint per acre when cotton is at least 6 inches tall up to 1 to 1 ½ pints per acre when cotton is at least 8 inches tall and emerged weeds do not exceed 2 inches in height; add 1 pint surfactant for each 25 gallons spray mixture. If needed, a second application of same rate may be made one week or later after initial treatment. Alternatively, after cotton is 20 inches tall, make a single application of 2 to 3 pints per acre following last cultivation; if emerged weeds are present, add surfactant as directed above. **NOTE:** Do not use on Pima varieties of cotton.

IMPORTANT: All applicable directions, restrictions, or precautions on the EPA registered label are to be followed. This labeling contains new or supplemental instructions for use of this product which may not appear on the package label. Follow instructions carefully. This labeling must be in the possession of the user at the time of pesticide application.
