Griffin Corporation is submitting a *notification* for Manex<sup>®</sup> (EPA Reg. No. 1812-251), in accordance with PR Notice 95-2.

We are clarifying the disease terminology under the fruit crop *grape* from "deadarm" to "phomopsis" (page 9 of the label). The older common name "deadarm" is less exact than the "phomopsis" name which is more generally used.

This notification also incorporates Agency requested changes as a condition of approval for our previous amendment (accepted August 30, 1996). We have deleted the walnut use (previously located on page 10), and requirements have been defined in the "Non-Agricultural Use Requirements" box (page 4).

In support of this *notification*, please find enclosed an *Application for Registration* (EPA Form 8570-1) and one (1) copy of revised labeling with the proposed additions highlighted and deletions struck.

Do not apply when wind speed favors drift beyond the area intended for treatment.

# Specific Instructions for Sprinkler Irrigation Systems

The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of liquid back toward the injection pump.
