GENERAL INSTRUCTIONS

MIXING

Before adding DU-TER FLOWABLE to the spray tank, partially fill with water. Add the desired amount of DU-TER FLOWABLE according to the rates listed elsewhere. After mixing thoroughly, add remaining water to spray tank. Continuous agitation within the spray tank is essential. If used in combination with a wettable powder product place the wettable powder in partially filled tank first, if a liquid, add DU-TER FLOWABLE to tank first.

APPLICATION METHODS

GROUND — Mix with water for a total solution of 10-100 gallons per acre.

AERIAL - Mix with water for a total solution of 3-20 gallons per acre.

SPRINKLER IRRIGATION — In non-mobile systems, application may be made as a part of the usual irrigation or as a separate treatment to prevent backsiphoning of pesticide into water source. Any irrigation water treated with this product should be held on the treated area until it is absorbed by the soil. It should not be turned into the tail water or fed back into the irrigation system.

IRRIGATION EQUIPMENT — Tank connected to the suction side of irrigation pump, field sprayer or other pressurized equipment connected to the main irrigation line may be used for injection. Good agitation must be provided in injection tank.

CALIBRATION AND USE IN SET SYSTEMS AND OTHER NON-MOBILE SYSTEMS:

- 1. Measure acreage covered by sprinklers.
- 2. Operate solid-set irrigation system and injection equipment at normal pressures.
- 3. Fill tank of injection equipment.
- Adjust flow from injection equipment to use contents over a period of 10 to 30 minutes.
- 5. For application of DU-TER FLOWABLE, mix desired amount of product for acreage to be covered (see chart for rates per acre, timing, stages of grow h and other information) into quantity of water used during phor calibration and operate entire system for amount of time established during calibration. DU-TER FLOWABLE should be injected at the end of the irrigation cycle or as a separate application.
- Stop injection equipment after treatment is completed and continue to operate irrigation system until DU-TER FLOWABLE has been cleared from the last sprinkler head. Refer to dye method of timing discussed below.

CALIBRATION AND USE IN CENTER-PIVOT AND OTHER MOBILE SYSTEMS:


- 3. Operate center-pivot system and injection equipment at normal pressures.
- 2. Fill tank of injection equipment.

- a) For systems other than center-pivot, operata entire system for one complete
 trip, measure time required, amount of water used from injection tank and acreage
 covered.
- b) For center-pivot systems, the water flow, speeds acreage and other capabilities
 of the system are given in the manual or should be determined.
- 4. For application of DU-TER FLOWABLE mix desired amount of product for acreage to be covered (see chart for rates), into quantity of water used during prior calibration and inject into system continuously for one complete revolution of the field.
- 5. If irrigation is to be stopped after DU-TER FLOWABLE has been applied, shut off the injection equipment after treatment is completed and continue to operate irrigation system until DU-TER FLOWABLE has been cleared from the last sprinkler head. Refer to dye method discussed below.
- 6. With mobile systems, irrigation may be continued after injection has been stopped.

DYE CALIBRATION

A recommended procedure for establishing the time which will elapse from stopping the injection of DU-TER FLOWABLE to its clearance from the last sprinkler is as follows:

- During calibration of injection equipment as described above, insert a water soluble Food, Drug and Cosmetic approved dye into the irrigation line at the injection point and record the time it takes for the dye to be released from the last sprinkler head.
- Collection of water from the last sprinkler in a glass jar will assist in observing when dyed water reaches that point.
