Figure 1. The effect of the concentration of the *Agrobacterium* strain on the transformation efficiency of *Agrobacterium* strain 10101. The *Agrobacterium* strain 10101 was cultured in the YEA medium for 24 h and then the cell concentration was adjusted to 100% (OD₆₀₀ = 0.6). The cell suspension was then diluted to 10%, 20%, 30%, 40%, 50%, 60%, 70%, 80%, 90%, and 100% of the original concentration. The cell suspension was then used to transform the *Agrobacterium* strain 10101. The transformation efficiency was determined by the number of transformants per 100 cells. The results are shown in Table 1.

COMPATIBILITY

To determine compatibility, add one teaspoon of ME TURON 41 to one pint of refrigerant solution (equals approximately 2 quarts or 20 gallons). Following either refrigerant solution, adjust compatibility test amounts proportionally. Stir or shake thoroughly. Let stand 5 minutes. If it remains mixed or can be removed readily, the mixture is compatible and can be used. If ME TURON 41 agglomerates out when mixed with refrigerant solution, a suspensibility agent may improve compatibility. Add suspensibility agent to the compatibility test to determine its effectiveness.

1. 4. bypass of the hand agitation in the spray tank. Avoid foaming spray mixture in tank without constant agitation. If bypass agitation is used, it should be maintained at the bottom of the tank to minimize foaming. Wash sprayer thoroughly with clean water immediately after use.

Thoroughly clean sprayer prior to use. Do not use a sprayer contaminated with 2, 3, 4-D or other herbicides. To improve the spray droplet size and distribution use fan type nozzles. Use 40 mesh or finer screen in nozzles and strainers. Use a suitable pump with capacity to deliver the necessary volume to the nozzles at 35 to 40 psi and 2 to 4 additional volume to maintain the mixture in suspension in the spray tank. Apply 1 to 2 to 10 gallons of spray mixture per acre.
