Use Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant as noted below. When using Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant to control algae, there are many factors to consider, water hardness, temperature of the water, kind and amount of vegetation to be controlled and the amount of water flow.

Algae can be controlled more easily and effectively if treatment with copper sulfate pentahydrate Blue Viking Copper Sulfate Instant is made soon after plant growth has started. Small amounts of copper sulfate pentahydrate Blue Viking Copper Sulfate Instant can effectively control algae in water. However, if treatment is delayed until a large amount of algae is present, larger quantities of copper sulfate pentahydrate Blue Viking Copper/Sulfate Instant may be required. Control of algae in water systems is not always permanent. Usually algae is more difficult to control with copper sulfate pentahydrate Blue Viking Copper Sulfate Instant when water temperatures are low. The dose rates recommended for Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant are based on water temperatures of 60°F or above. Larger quantities of copper subate pentahydrate Blue Viking Copper Sulfate Instant will also be required in hard water. Normally, larger quantities of copper sulfate pentahydrate Blue Viking Copper Sulfate Instant will be required to kill algae in water which is flowing than in a body of stagnant water. If possible, curtail the flow of water before treatment and hold dormant for approximately three days after treatment or until the plants have begun to die. It is usually best to treat algae on a sunny day when the heavy mats of filamentary algae are most likely to be floating on the surface where it can be sprayed directly. If there is some doubt about the concentration to apply, it is generally best to start with a lower concentration and to increase this concentration until the algae is killed.

NOTE: When preparing a copper sulfate pentahydrate Blue Viking Copper Sulfate Instant solution in water, it is best that the mixing container be made of glass or plastic or if a metal container is used, that it be either painted, enameled, or copper-lined. The use of a galvanized container causes a chemical reaction to take place by which the copper displaces the galvanized coating of the container.

**NOTE:** Agricultural chemicals may perform in an unpredictable manner when tank mixed, especially where several products are involved. Reduced effect on pests or crop injury may occur. Calculate water volume as follows:

- 1. Obtain surface area by measuring of regular shaped ponds or mapping of irregular ponds or by reference to previously recorded engineering data or maps.
- 2. Calculate average depth by sounding in a regular pattern and taking the mean of these readings or by reference to previously obtained data.
- 3. Multiply surface area in feet by average depth in feet to obtain cubic feet of water volume.
- 4. Multiply surface area in acres by average depth in feet to obtain total acre-feet of water volume.

**NOTE:** If treated water is to be used as a source of potable water, the metallic copper residual must not exceed 1 ppm (4 ppm copper sulfate pentahydrate).

Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant can be used in Slow Moving or Quiescent Bodies of Water Including: Lakes; Potable Water Reservoirs; Golf, Farm, Fish and Fire Ponds; Fish Hatcheries; and Crop and Non-Crop Irrigation Conveyance Systems, Ditches, Canals and Laterals.

- Application by Dragging under Water Blue Viking Copper Sulfate Instanticated applied by dragging them invarious policing mesh bag lattached to allow the tops foot of water in the crystals are suspended in the tops foot of water in the crystals are dissolved. Drag the bag of crystals first near the shoreline and continue outward by moving as the boat travels in parallel lines about 20 to 100 feet apart until area has been treated or until 1/3 to 1/2 of the surface area has been treated. Continue dragging bag over treated area until the required minimum dose is applied and all crystals are dissolved. Determine the quantity of crystals needed to treat the problem area following direction and cautions on this label.
- Application by Spraying Solution on Water Surface: Dissolve the minimum required dose of Blue Viking Copper Sulfate Instant in water and spray the solution uniformly over the body of water. When spraying a solution of Blue Viking Copper Sulfate Instant, mix product in sufficient water to the loughly spray the water surface. While the volume per surface acre depends on the type of spray equipment being used, spray volume should be approximately 20 to 500 or more gallons per acre of surface water. Several types of solutioning and spraying equipment may be used. Observe previous cautions on the effect of Blue Viking Copper Sulfate Instant solution on various metals in spraying containers.
- 3. Application by Broadcasting: Dry Blue Viking Copper Sulfate Instant can be broadcast on the water surface using a properly equipped boat. An air blower can be used to discharge these crystals at a specific rate over the surface of the water. When using this method, the wind direction is an important factor. Do not use this method unless completely familiar with this type of application.

4. Application by Spraying from Airplanes and Helicopters: Professional personnel licensed by the State Agricultural Extension Service are allowed to apply dry Blue Viking Copper Sulfate Instant in some states.

CROP AND NON-CROP IRRIGATION CONVEYANCE SYSTEMS, DITCHES, CANALS AND LATERALS. Blue Viking Copper Sulfate instant controls the Potomogeton Rondweeds, leafy and sago. Use the continuous application method applying 1.6 to 244 lbs percubic foot per second per day.

CONTROL OF ALGAE IN RICE/WILD RICE FIELDS - Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant is recommended for control of Filamentous and Planktonic Algae in rice/wild rice fields. Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant should be applied at a rate of 10 to 15 pounds per acre using boat, plane or other professional device. Use at first sign of algae after the field has been flooded to a depth of 6-8 inches. Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant is especially graded for maximum solubility in this volume of water.

#### **CONTROL OF TADPOLE SHRIMP**

Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant is recommended for the control of tadpole shrimp in rice fields. Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant should be applied at a rate of 5 to 10 pounds per acre either dry or dissolved in water using boat, plane or other professional device. Use at the first indication of infestation after the field has been flooded and continue as needed.

#### SEWER TREATMENT - ROOT DESTROYER\*

To control root growth in sewers\*: Commercial, Institutional, and Municipal Sewers use as follows:

SEWERS - Use 2 pounds of Blue Viking Copper Sulfate Instant every 6 to 12 months, applied into each junction or terminal manhole as a preventive measure. Add Blue Viking Copper Sulfate Instant during period of reduced flow; however, a small flow is essential. If reduced flow due to root masses is observed, but not completely stopped, add the Blue Viking Copper Sulfate Instant in the next manhole above the reduced flow area. If completely blocked, use a rod to penetrate the mass so some flow begins before treatment.

STORM DRAINS: Use 2 pounds of Blue Viking Copper Sulfate Instant per drain per year.

Apply during a period of light water flow. In dry weather, introduce a flow with a hose if storm drains become almost plugged, repeat treatment 3 or 4 times at 2 week intervals.

SEWER PUMPS AND FORCE MAINS - Place 2 pounds of Blue Viking Copper Sulfate Instant in a cloth bag at the storage well-inlet. Repeat/assneeded:

For partial stoppage add 0.5 pound of Blue Viking Star Shine Crystals to sewer or drain and flush toward blockage with 5 gallons of water. Repeat at 6 month intervals to prevent growth of new roots.

For complete stoppage, physically remove the root blockage and repeat as above.

#### WOOD TREATMENT (green, peeled posts)

Fungus, Decay, Rot - Prepare a solution of 18 pounds of sodium chromate in each 26 gallons of water to be used and a separate second solution of 18 pounds of copper sulfate pentahydrate. Blue Viking Copper Sulfate Instant in each 24 gallons of water to be used; soak the peeled, green posts, butt end down first in the copper sulfate Blue Viking Copper Sulfate Instant solution for 3 days, then butt end down in the sodium chromate solution for 2 days, and finally turn the post upside down in the sodium chromate solution for 1 additional day, remove and rinse posts with clear water.

#### **BORDEAUX SPRAY MIXTURE**

How to Understand Bordeaux Formulations - If the Bordeaux Mixture instructions reads 10-10-100, the first figure means the number of pounds of copper sulfate pentahydrate Blue Viking Copper Sulfate Instant. The second figure means the pounds of hydrated spray lime, and the third figure, the gallons of water to be used. Use as a full coverage spray to runoff.

How to Prepare a Bordeaux Mixture - To prepare a Bordeaux mixture, fill a tank with water, one quarter full. Then with agitator running, mix in Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant through a copper, bronze, stainless steel or plastic screen. Add water so the tank is three quarters full. Mix in the hydrated spray lime through the screen and finish filling the tank with water.

#### **CROP USE RECOMMENDATIONS**

ALMOND, APRICOT, PEACH, NECTARINE: Shot Hole Fungus - Prepare a 10-10-100 Bordeaux and apply as a dormant spray in late fall or early spring.

ALMOND, APRICOT, CHERRY, PEACH, NECTARINE, PLUM, PRUNE: Brown Rot Biossom Blight - Prepare a 10-10-100 Bordeaux and apply when buds begin to swell.

APPLES: Fireblight - Mix 5 lbs. of Blue Viking Copper Sulfate Instant in 100 gallons of water and spray uniformly to the point of runoff. Apply in dormant only at silver tip stage. After silver tip severe burn will occur on any exposed green tissue and lime to make a Bordeaux spray for this treatment.

BULBS (EASTER LILY, TULIP, GLADIOLUS) Botrytis blight Prepare at 10-100 Bordeaux and apply as a foliar spray to one acres. Apply for thorough coverage beginning at the first sign of disease and repeat as needed to control disease at 3 to 10 day intervals. Luse the shorter intervals during periods of frequent lains or when severe disease conditions persists. Avoid spray just be located to the green as a problem.

GHERRIES (SWEET): Dead bud: Bacterial canker (Rseddomonas syringae) the pare lattice 12-100 Bordeaux Apply acterial and again in late winter be of above specific to well we cool Northwest U-Sy winters; a third spray may be needed between above sprays.

CHERRY (SOUR): Leaf Spot - Prepare a 10-10-100 Bordeaux. Apply as a full coverage spray after petal fall or as recommended by the State Extension Service.

GRAPES (EXGERT GALIFORNIA): Downy Mildew Prepare and apply a 2 6 100 Bordeaux spray beginning when downy mildew is detected to receive and maintain control. This mixture and its use will exhibit some phytotoxicity on most varieties.

GRAPES (DORMANT): Powdery mildew Apply in spring before bud-swell and before any green tissue is present. Use 4 to 8 lbs. of Blue Viking Copper Sulfate Instant per 100 gallons of water. Apply in a high volume spray of 300 gallons water per acre. Direct spray to thoroughly wet the dormant vine, especially the bark of the trunk, head, or cordons.

OLIVES: Olive leaf spot (Peacock spot), Olive knot - Prepare a 10-10-100 Bordeaux spray and apply up to 500 gallons per acre. Apply before fall rains begin, usually late October or early November in California. In wet winters, a repeat spray may be needed in nid-winter. In areas with less than 10 inches of annual rainfall, a 5-5-100 Bordeaux spray applied in up to 500 gallons per acre may be used.

**PEACHES:** Leaf curl - Prepare a 10-10-100 Bordeaux and apply at leaf fall or as a dormant spray in late fall or early spring before buds begin to swell. If above sprays for Coryneum blight are made, peach leaf curl also will be controlled.

WALNUTS: Walnut Blight - Apply 15 pounds with 10 pounds of lime in 100 gallons of water. Make application in early pre-bloom before catkin blooms are showing (10-20% pistillate) before or after rain. Use only if Bordeaux mixture has been shown to be non-phytotoxic in your area. If desired, add one-half gallon summer oil emulsion per 100 gallons of water. PRECAUTION: Addition of summer oil emulsion to pre-bloom and early bloom sprays may result in plant injury.

#### **CITRUS**

NOTE: Adding foliar nutritionals to spray mixtures containing Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant or other products and applying to citrus during the post bloom period when young fruit is present may result in spray burn.

Bacterial blast: Prepare a 10-10-100 Bordeaux spray and apply a spray in lare Cotober to early November or before fall rains begins Make a complete coverage spray using hono 25 gallons per mature tree.

LEMON, ORANGE, GRAPEFRUIT: Phytophthora Brown Rot - Prepare a 3-4.5-100 Bordeaux where there is no history of copper injury or a 3-2-6-100 (Zinc Sulfate-Copper Sulfate Pentahydrate Blue Viking Copper Sulfate Instant-Hydrated Lime-Gallons of water) Bordeaux. Spray 6 gallons on skirt of tree 3 to 4 feet high and 2 to 4 gallons on trunk and ground under tree. If P. Hibernalis is present, use 10 to 25 gallons to completely cover each tree. Apply in November or December just before or after first rain. In severe Brown Rot season, apply second application in January or February.

LEMON, ORANGE, GRAPEFRUIT: Septoria Fruit and Leaf Spot; Central California - Brown Rot and Zinc and Copper Deficiencies - Prepare a 3-2-6-100 Bordeaux and use 10 to 25 gallons to completely cover each tree. Apply in October, November or December before or just after first rain.

#### **POTATO VINE KILL**

Apply 10 lb/acre in 10 to 100 gallons of water (ground equipment) or in 5 to 10 gallons (aerial equipment) with Diquat at vine-kill to enhance vine desiccation and suppress late blight. Additional applications can be made with Diquat if needed to within 7 days of harvest. Blue Viking Star Shine Crystals Blue Viking Copper Sulfate Instant may be applied alone until harvest to suppress late blight.

**NOTE:** This product can be mixed with Diquat for use on potatoes in accordance with the most restrictive of label limitations and precautions. No label dosage rates should be exceeded.
