STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Hold eyelids open and flush with a gentle stream of water for at least 15 minutes. Get medical attention, preferably an ophthalmologist.

✓ **IF ON SKIN:** Immediately wash with plenty of soap and water. Get medical attention.

IF SWALLOWED: Do not induce vomiting or give anything by mouth to an unconscious person. Promptly drink a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration.

Administer oxygen if necessary. Get medical attention.

NOTE TO PHYSICIAN

There is no specific antidote. All treatment should be based on observed signs and symptoms of distress in the patient. Over exposure to materials other than this product may have occurred.

Victims of severe overexposure, by inhalation, should be kept under observation for up to 72 hours for delayed onset of pulmonary edema. In a victim of overexposure by ingestion, careful gastric lavage is required due to the possibility of stomach or esophageal perforation. Probable mucousal damage may contraindicate the use of gastric lavage. This material is an acid, but use of alkaline substances to neutralize it is contraindicated.
