Enclosed, please find form 8570-1 and (3) copies each of the revised labeling (TL-48 042604 03/29/04, TL-49 042604 03/29/04) for Griffin L.L.C. Linuron Flake technical (EPA Reg. No. 1812-411). Please note that (2) labels are being submitted, one label for product manufactured in Israel (EPA Est. 11603-IS-1) and one label for product manufactured in Italy (EPA Est. 33660-IT-1). The only substantive change made was to correct the manufacturing country. The statement 'Made in USA' has been changed to 'Made in Israel' and 'Made in Italy' respectfully. This is a correction to our submission of final printed labeling dated April 27, 2004.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
