### STATEMENT OF PRACTICAL TREATMENT

If swallowed: Call a physician or Poison Control Center immediately. Do not induce vomiting. Rinse mouth with water. Dilute by giving 1 or 2 glasses of water. Do not give anything by mouth to an unconscious person.

If on skin: Wash with plenty of soap and water. Get medical attention.

If Inhaled: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

If in eyes: Immediately flush with plenty of water. Obtain medical attention if irritation occurs and persists.

### Note to Physician

Chlorpyrifos is a reversible cholinesterase inhibitor. Atropine sulfate is antidotal. Start treatment by giving 2 mg atropine by injection after cyanosis is overcome and repeat atropine at 0.4 to 2 mg every 15 minutes until atropinization is achieved (tachycardis, flushing, dry mouth and mydriasis). Oximes, such as 2-PAM/protopam, are also antidotal, but only in conjunction with atropine. Observe to insure symptoms do not recur as atropinization wears off. Morphine, theophylline, phenothiazines and reserpine are probably contraindicated. This product also contains lightweight aromatic hydrocarbons that can produce a severe pneumonitis if aspirated during emesis. Consideration should be given to gastric lavage with endotracheal tube in place. Treatment is controlled by removal of exposure followed by antidotal, symptomatic and supportive care.
