Griffin further agrees that such hearing may be held under the expedited procedures set forth in 40 C.F.R. Part 164, Subpart C.
- 8. If EPA grants a registration for a substantially similar product containing Sulfluramid with terms and conditions that differ from this registration, Griffin may request conforming amendments to this AB MUP registration.

Follow with: "Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor".


