On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A), since you agreed to the following:

1. This registration is time-limited and automatically expires on December 31, 2016.
2. The active ingredient in this Termite MUP shall be drawn solely [REDACTED] as of the effective date of this Termite MUP registration. The Confidential Statement of Formula (CSF) dated May 31, 2001 is the CSF of record and replaces all previously submitted CSFs. This CSF shall not be amended to change [REDACTED].
3. Griffin shall not [REDACTED] any Sulfluramid active ingredient for domestic use, domestic sale or domestic distribution of pesticides. Notwithstanding this condition, Griffin may (1) import end-use or

intermediate products formulated [REDACTED] of Sulfluramid active ingredient for sale and distribution in the United States and (2) [REDACTED] Sulfluramid active ingredient to produce Sulfluramid product(s) for export purposes only, consistent with FIFRA section 17 and any applicable regulations.

4. Griffin shall file with EPA's Office of Pesticide Program by March 1st of each calendar year a report in which Griffin certifies to EPA the total amount [REDACTED] of Sulfluramid active ingredient sold as Termite MUP in the previous calendar year. Additionally, Griffin shall certify by March 1st of each calendar year, how much [REDACTED] Sulfluramid active ingredient [REDACTED].
5. In the event that Griffin's [REDACTED] Sulfluramid active ingredient is exhausted before the expiration of this registration, Griffin shall submit a FIFRA section 6(f) request for this termite MUP within six months of exhaustion of its supply of Sulfluramid active ingredient. In the alternative, if there are no registrations of end-use termite bait products that would use this termite MUP as a source of active ingredient, Griffin shall submit a FIFRA section 6(f) request for this termite MUP. If neither of these events occurs, Griffin shall file a FIFRA section 6(f) request for the termite MUP no later than July 31, 2016.
6. Once Griffin files a 6(f) notice based on any of the events specified in condition (5), existing stocks will be permitted for one year. Within 14 (fourteen) days of filing its FIFRA section 6(f) request, Griffin shall notify all registrants who use this termite MUP for formulation into end-use products that Griffin has filed the FIFRA section 6(f) request.
7. If EPA proposes to cancel this registration for violation of one of the foregoing conditions, Griffin agrees that the only issue to be considered at the cancellation hearing shall be whether Griffin violated the specific condition at issue. Griffin further agrees that such hearing may be held under the expedited procedures set forth in 40 C.F.R. Part 164, Subpart C.
8. If EPA grants a registration for a substantially similar product containing Sulfluramid with terms and conditions that differ from this registration, Griffin may request conforming amendments.

Make the following label changes:

- a. Revise the EPA Registration Number to read, "EPA Reg. No. 1812-452".
- b. Per PR Notice 2001-1, revise the label STATEMENT OF PRACTICAL TREATMENT as follows: IF SWALLOWED: "Call a poison control center or doctor immediately for treatment advice" to the end of the first sentence. Follow with: "Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor".

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center for treatment advice. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice."

Also, add the following statement near the first aid statements: "Have the product container or label with you when calling a poison control center or doctor or going for treatment."

EPA recommends that these statements be boxed and bulleted to present the information in a clear, easy-to-read fashion.

- c. Label must read: "For use only in formulating termite bait stations. This Manufacturing Use Product may not be formulated into any end-use product with instructions for any other use. If the termite bait station is for residential use, the product must be in Child Resistant Packaging."

Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

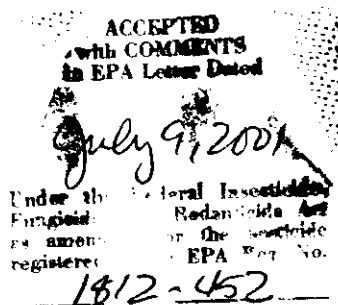
