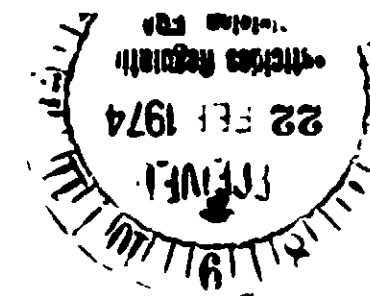

For use as a residual insecticide against roaches, ants, silverfish, spiders, waterbugs.

**ACTIVE INGREDIENTS**

Deodorized petroleum distillate	98.86%
0,0-Diethyl O-(2-Isopropyl-4-methyl-6-pyrimidinyl) phosphorothioate	0.50%
Aromatic petroleum derivative solvent	0.40%

**INERT INGREDIENTS**

0.24%

**DIRECTIONS FOR USE:**

COCKROACHES, WATERBUGS, ANTS, SILVERFISH - Make spot applications of Diazinon Residual as a coarse spray or apply with a paint brush to baseboards, around water pipes, cracks, crevices, behind refrigerators, sinks, stoves, and similar areas where these insects hide. Repeat as necessary.

SPIDERS - Apply Diazinon Residual spray around windows, doors, baseboards and to other areas where these insects may crawl. Repeat as necessary.

APPLICATIONS WITHIN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS - LIMITED TO CRACK AND CREVICE TREATMENT ONLY - Apply a small amount of material directly into cracks and crevices such as expansion joint between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where cockroaches, waterbugs, ants, silverfish, and spiders hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food processing surfaces.

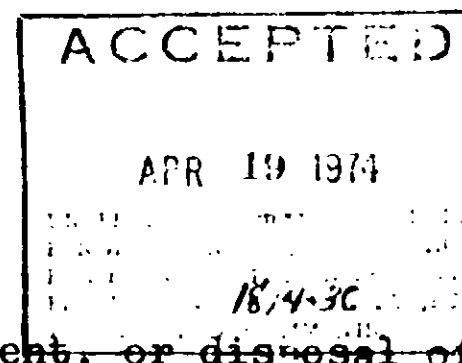
Applications of this product in the food areas of food handling establishments, other than as a crack and crevice treatment, are not permitted.
