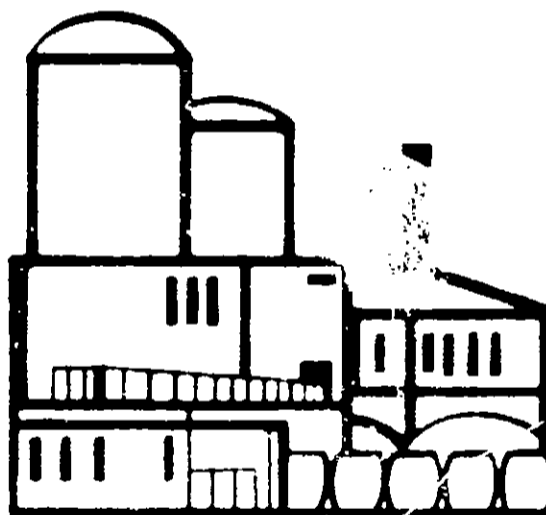

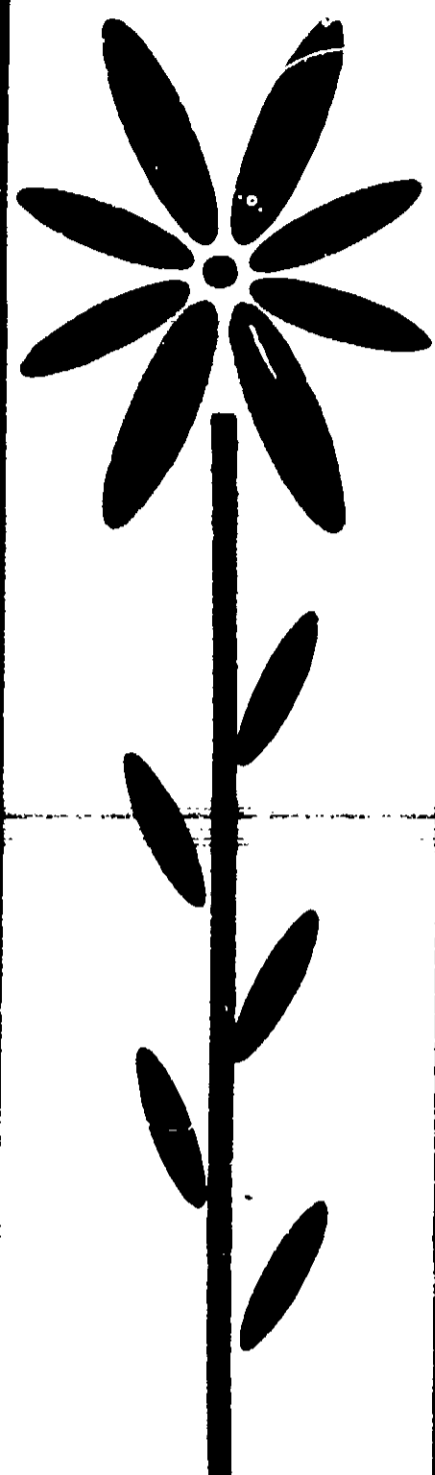

DIRECTIONS FOR USE

DAIRY AND MILK PROCESSING PLANTS—CREAMERY, ICE CREAM,
 CHEESE PLANTS, BREWERIES—CARBONATED BEVERAGE—
 FOOD PROCESSING PLANTS

1. FLUSH utensils and equipment with clean water. 2. WASH with recommended Turco product. 3. RINSE with clean water. 4. SANITIZE immediately with Turcosan-2, 150 p.p.m. available chlorine, by immersion or flow contact for 2 minutes, or as required by governing sanitary code. Rinse with potable water before using.

EATING and DRINKING ESTABLISHMENTS

1. SCRAPE and PREFLUSH all articles to be washed.
2. WASH with suitable Turco product.
3. RINSE thoroughly with clean water.
4. SANITIZE by immersion in Turcosan-2 solution containing 1½ oz. of Turcosan-2 for each 15 gals. of water (provides 150 p.p.m. available chlorine), for 2 min., or as otherwise specified in the governing sanitary code.
5. RINSE thoroughly with potable water before reuse.
6. AIR-DRY on clean drain board.

MAINTENANCE — SANITATION — DEODORIZING

FOR DEODORIZING and DISINFECTING Floors, Walls, Cold Storage Rooms, Refrigerators, General Storage Areas, Refuse Containers, Baths, Showers. 1. WASH all surfaces with recommended Turco product. 2. RINSE well with clean water. 3. DISINFECT with Turcosan-2 solution, 400 p.p.m. available chlorine (4 ounces to 15 gallons water) by thoroughly rinsing or spraying all surfaces with solution. 4. RINSE thoroughly with potable water after treatment of food contact surfaces.

Rinse container well with water when empty. Do not re-use container.

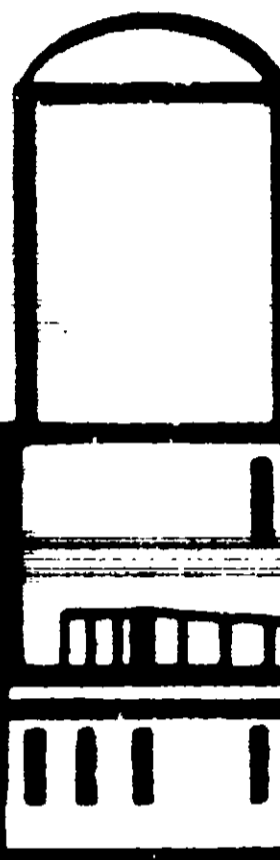
