The amendment (label and CSF of 8-27-96 update) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, acceptable provided that you:

- 1. Make the following labeling changes below before you release the product for shipment bearing the amended labeling.
- a. Delete the word: Germicide. This product is not a germicide. This product is a manufacturing/formulating use product.
- b. Delete the word: concentrated.
- c. Delete the phrase "...or absorbed through skin."
- d. Delete the letter "s". Only one active ingredient is declared on the label.
- e. The headings:

KEEP OUT OF REACH OF CHILDREN DANGER

must be placed directly below the ingredient statement section: (Front Panel only)

- f. Add the statement: "Do not use water containing residues from the use of this product to irrigate crops for food or feed."
- g. The preferred nomenclature for the active ingredient "Alkyl..." not "n-Alkyl...".

- 2. A release for shipment of the product bearing the amended labeling constitues acceptance of these conditions.
- 3. It has been noted for the record that the Ethanol in this product is not an active ingredient and has been placed into the inert ingredient section.
- 4. Our records have been adjusted to reflect your product name change:
