

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Powder Detergent/Disinfectant is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection specifically for hospitals, nursing homes, and other institutions where housekeeping is of prime importance in controlling the hazard of cross-contamination.

This product, when used as directed, is formulated to disinfect inanimate, hard nonporous surfaces such as walls, floors, sink tops, tables, and chairs. For larger areas such as operating rooms, patient care facilities, and restrooms, this product is designed to provide both general cleaning and disinfection.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, and any other areas which are prone to odors caused by microorganisms.

PACKETS - Tear open packet-follow label dilution instructions and discard opened packet according to label disposal instructions.

Water soluble packet-follow label dilution instructions by dropping packet directly into water. Do not remove packets before use. Store in cool dry place. Do not handle packets with wet hands.

DISINFECTION - To disinfect inanimate, hard nonporous surfaces add one (1/8 oz., 5.75 gm or 1/2 oz.) pre-measured packet of product or measure powder at the following use dilutions:

Add this amount of product:	1/8 ounce (3.55 grams)	5.75 grams	1/2 ounce	1 ounce	1 1/2 ounces
in warm water to make:	One Quart	52 ounces	1 Gallon	2 Gallons	3 Gallons

Stir gently to form a uniform solution. Apply solution with a mop, cloth, sponge or hand pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes and then let air dry.

For heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution for each use.

BACTERICIDAL ACTIVITY - At the stated Disinfection dilution rate, this product exhibits effective disinfectant activity against the organisms: Pseudomonas aeruginosa PRD-10, Escherichia coli, Klebsiella pneumoniae, Salmonella schottmuelleri, Salmonella choleraesuis, Brevibacterium ammoniagenes, Streptococcus faecalis, Shigella dysenteriae, Staphylococcus aureus, Enterobacter aerogenes and meets all requirements for hospital use.

MILDEWSTAT - To control mold and mildew on pre-cleaned, hard, nonporous surfaces mix this product at the stated dilution rate for Disinfection. Apply solution with a mop, cloth, sponge or hand pump trigger sprayer making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth appears. At the disinfectant dilution rate, this product is also fungicidal against the pathogenic fungi, Trichophyton mentagrophytes.

VIRUCIDAL ACTIVITY - This product, when used on environmental, inanimate, hard surfaces at the Disinfectant dilution rate, exhibits effective virucidal activity against HIV-1, Influenza A₂, Parainfluenza Type 1 (Sendai), Canine Distemper, Feline Pneumonitis, Vaccinia virus, Herpes Simplex Type 1.

KILLS HIV-1 ON PRE-CLEANED ENVIRONMENTAL SURFACES/OBJECTS PREVIOUSLY SOILED WITH BLOOD/BODY FLUIDS in health care settings (Hospitals, Nursing Homes) or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of Human Immunodeficiency Virus Type 1 (HIV-1) (associated with AIDS).

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS.
DANGER

KEEP OUT OF REACH OF CHILDREN. CORROSIVE. Causes irreversible eye damage and skin burns. Do not get in eyes, or skin or on clothing. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
