DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

CD 1.6 (D&F) Detergent/Disinfectant is designed to provide effective cleaning, deodorizing, and disinfection specifically for hospitals, nursing homes, schools, animal quarters, kennels, food processing plants, food service establishments, transportation terminals, office buildings, manufacturing facilities, lodging establishments, retail businesses and athletic/recreational facilities where housekeeping is of prime importance in controlling the hazard of cross contamination.

When used as directed, this product is formulated to disinfect hard, non-porous, inanimate, environmental surfaces: floors, walls, metal surfaces, stainless steel surfaces, glazed porcelain, glazed ceramic tile, plastic surfaces, bathrooms, shower stalls, bathtubs, cabinets, tables, chairs, and telephones. For larger areas: operating rooms, patient care facilities and restrooms, this product is designed to provide both general cleaning and disinfecting.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls and other areas which are prone to odors caused by microorganisms.

This product is not to be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. DISINFECTION - To disinfect hard inanimate surfaces apply solution with a mop, cloth, sponge or hand pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes and then let air dry.

DISINFECTION - To disinfect hard, inanimate, non-porous surfaces apply solution with a mop, cloth, sponge or hand pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes and then let air dry.

GENERAL DISINFECTION - Add 4.5 ounces of this product per gallon of water.

HOSPITAL DISINFECTION - Add 6 ounces of this product per gallon of water.

or heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution for each use.

FOR DISINFECTION AGAINST CANINE PARVOVIRUS - Add 18 ounces of this product per gallon of water.

To disinfect toilet bowls: Remove gross filth or soils from surfaces with bowl brush. Add 4.5 ounces of this product directly to the bowl water. Brush or swab the bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

To disinfect food processing premises: floors, walls, and storage areas, add 4.5 ounces of this product per gallon of water. For heavily soiled areas, a pre-cleaning step is required. Apply solution with a mop, cloth, sponge or hand pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes, then remove excess liquid. Before using this product, food products and packaging materials must be removed from the area or carefully protected. After use, all surfaces in the area must be thoroughly rinsed with potable water.

To disinfect food service establishment food contact surfaces: countertops, appliances, tables, add 4.5 ounces of this product per gallon of water. For heavily soiled areas, a pre-cleaning step is required. Apply solution with a cloth, sponge or hand pump trigger sprayer so as to wet all surfaces thoroughly. Allow the surface to remain wet for 10 minutes, then remove excess liquid and rinse the surface with potable water. This product can not be used to clean the following food contact surfaces: utensils, glassware and dishes.

DISINFECTION OF POULTRY EQUIPMENT, ANIMAL QUARTERS AND KENNELS - For disinfection of pre-cleaned poultry quipment (brooders, watering founts, feeding equipment), animal quarters and kennels, apply a solution of 6 ounces of this product per gallon of water. Remove all poultry, animals, and feed from premises, trucks, coops, and crates. Remove all litter and droppings from floors, walls and surfaces of facilities occupied or traversed by poultry or animals. Empty all troughs, racks, and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate the surfaces with the disinfecting solution for a period of 10 minutes. Ventilate building, coops, and other closed spaces. Do not house poultry or animals or employ equipment until treatment has been absorbed, set or dried. All treated equipment that will contact feed or drinking water must be rinsed with potable water before reuse.

BACTERICIDAL ACTIVITY - When diluted at the rate of 4.5 ounces per gallon of water, this product exhibits disinfectant activity against the organisms: Salmonella choleraesuis. Staphylococcus aureus and Escherichia coli. When diluted at the rate of 6 ounces per gallon of water, this product exhibits effective disinfectant activity against Pseudomonas aeruginosa in addition to the above microorganisms and meets all requirements for hospital use.

*VIRUCIDAL ACTIVITY - This product, when used on environmental inanimate hard non-porous surfaces at a dilurion of 18 ounces per gallon of water exhibits effective virucidal activity against Canine Parvovirus.

MILDEWSTAT - To control mold and mildew (such as Aspergillus niger ATCC 6275) and the odors they cause on pre-cleaned, hard, non-porous inanimate surfaces add 4.5 ounces of this product per gallon of water. Apply solution with a cloth, mop or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth appears.

DANGER
