Add 5 fluid ounces of this product per 100 lbs. of dry laundry to the final rinse cycle water.

At this rate, this product provides, to the fabric, a residual <u>self-sanitizing</u> activity against odor-causing Gram positive and Gram negative organisms under conditions of high relative humidity or wet contamination.

Residual bacteriostatic level of bacterial control

Add 20 fluid ounces of this product per 100 lbs. of dry laundry to the final rinse cycle water.

At this rate, this product provides, to the fabric, a residual <u>bacteriostatic</u> activity against odor-causing Gram positive and Gram negative organisms under conditions of high relative humidity or wet contamination.

This product inhibits the growth of organisms which act on urine to produce ammonia in diapers and wet bed linens. It also softens clothes, thereby eliminating chafing and "static cling" from nylons and other synthetic fabrics. The use of this product will also help to improve ironing time.
