Add 2 ounces BTC 2125M Powdered Fabric Softener Sanitizer per 100 pounds of dry laundry in the final rinse cycle.

Fabric treated as directed will develop residual bacteriostatic activity and residual self-sanitizing activity against odor-causing Gram positive and Gram negative organisms under condition of high relative humidity or wet contamination. BTC 2125M Powdered Fabric Softener Sanitizer inhibits the growth of ammonia producing organisms which act on urine in the diapers to produce ammonia.  
BTC 2125M Powdered Fabric Softener Sanitizer inhibits the growth of Gram positive and Gram negative odor-causing organisms on wet bed linens of incontinent persons.
