#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

PT 4.0 Pine Scent Disinfectant/Detergent, formulated with a quaternary-pine oil combination, is a broad spectrum bactericide and fungicide for use in nursing homes, hospitals, schools, lodging establishments, transportation terminals, office buildings, manufacturing facilities, retail businesses, and athletic/recreational facilities, where housekeeping is of prime importance. This formulation provides effective cleaning, deodorization and disinfection of walls, floors, sink tops, toilet bowls, tables, chairs, and telephones. For larger areas such as operating rooms, patient care facilities, and restrooms, this product provides both general cleaning and disinfection.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls, sink tops, urinals, and other areas which are prone to odors caused by microorganisms.

This product may also be used as general cleaner for areas where a fresh pine scent is desirable.

(For labels that list medical premises and metal and/or stainless steel surfaces, one of the following statements must be used:) This product is not be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body.

This product is not for use on medical device surfaces.


**DISINFECTION** - To disinfect previously cleaned, inanimate, hard surfaces add 4 ounces of this product per gallon of water. Apply with a mop, cloth, sponge or hand pump trigger sprayer so as to wet thoroughly. Allow to remain wet for 10 minutes and then let air dry.

For heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution for each use.

To disinfect toilet bowls: pre-clean the bowl, flush toilet and add 4 ounces of this product directly to the bowl water. Swab the bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

BACTERICIDAL ACTIVITY - When diluted at the rate of 4 ounces per gallon of water, this product exhibits effective disinfectant activity against the organisms: Staphylococcus aureus, Salmonella choleraesuis and Pseudomonas aeruginosa and meets all requirements for hospital use.

**FUNGICIDAL ACTIVITY** - When diluted at the rate of 4 ounces per gallon of water, this product is effective against the pathogenic fungus, Trichophyton mentagrophytes (Athlete's Foot Fungus), on hard surfaces found in bathrooms, shower stalls, locker rooms, exercise facilities or other clean, non-porous, hard surfaces commonly contacted by bare feet.

#### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

#### DANGER

CORROSIVE. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin or on clothing. Wear goggles or face shield, rubber gloves, and protective clothing. May be fatal if swallowed. Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Remove contaminated clothing and wash clothing before reuse.

#### FIRST AID

If swallowed: Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
