The following amendment submitted in connection with registration of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the following comment.

Proposed Amendment

- Addition of specific end -use sites in accordance with PR Notice 91-8 and Draft 158, Subpart W, Appendix B
- Update First Aid statements per PR Notice 2001-1
- Update the Precautionary Statements consistent with Label Review Manual

Label Comments

1. Revise the Precautionary Statement language to read: Corrosive. Causes irreversible eye damage and skin and burns. Maybe fatal if inhaled. Harmful if absorbed through skin. Do not breathe vapor or spray mist. Wear a dust/mist filtering respirator (MHSA/NOSH approval number prefix TC-21C), or a NOSH approved respirator with any N, R, P, or HE filter. Do not get in eyes , on skin, or on clothing. Wear protective eyewear, clothing, and gloves (goggles face shield, safety glasses and rubber gloves). Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.


