The following amendment submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the following condition.

Proposed Amendment

- Revise the Precautionary Statements:
 - Change statement: May be fatal is swallowed or inhaled. Harmful is absorbed through skin. To read "may be fatal if swallowed, absorbed through the skin or inhaled."
 - Delete the statement "Harmful if absorbed through the skin"

Condition

Your product is an MUP which is intended for formulation into end use products. The term "Concentrated Germicide" is an efficacy claim that requires data to support the end use product registration. Therefore delete the claim "Concentrated Germicide" from the label.
