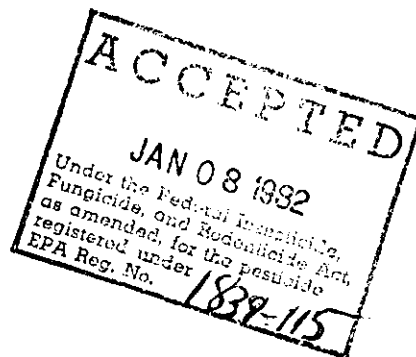
DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Onyxide 200 has been primarily designed for use in Oil Field applications such as drilling muds, completion fluids, hydrolic fracturing fluids and enhance recovery. This product is a long lasting bacteriostat and fungistat and is effective against aerobic, anaerobic and H_2S producing microorganisms. Onyxide 200 is water soluble and compatible with most fluid components.

Dilution Rates:

Add Onyxide 200 to provide a concentration of .05%-2% of Onyxide 200 (1/4 lbs. per barrel to 3/4 lbs. per barrel) in the final fluid.
