Dear Ms. Liu:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC 818-80% IS A CATIONIC MATERIAL.

Only for formulation into antimicrobial products for use in agricultural/farm premises, structures, buildings, and equipment; dairy farm milk handling facilities, equipment, storage rooms, houses and sheds; food processing plant, food handling, food distribution equipment and premises; mushroom houses/empty premises and equipment; egg handling equipment and rooms, egg washing treatment; poultry processing plant equipment/premises, meat processing plant/equipment, eating establishment premises and equipment; commercial, institutional, and industrial premises and equipment (floors, walls, storage areas); domestic dwellings, food handling areas, bathroom premises (hard surfaces), indoor premises; and medical institutional critical care and noncritical premises and laundry. For formulation into antimicrobial products for use in air conditioner/refrigeration condensate water systems, air washer and industrial scrubbing systems, once-through and recirculating industrial/commercial cooling water systems, pulp/paper mill water systems, swimming pools, greenhouses/nurseries, fountains/water displays/decorative ponds/standing water, disposal water, sewage treatment systems, spas, gas/oil drilling muds/packer fluids, gas/oil recovery injection water systems, gas/oil pipeline maintenance and gas/oil fracturing fluid systems. FIRST AID
