The following amendment, submitted in connection with registration under 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the comments listed below.

Proposed Amendment

- Update Label Language in Response to PR Notice 2001-1 (First Aid Statements)

Label Comments

1. Revise the Precautionary Statements to read: "DANGER, Keep Out of Reach of Children. Corrosive. Causes irreversible eye damage and skin burns. May be fatal if swallowed. Maybe fatal if inhaled. Harmful if absorbed through skin. *Do not breathe vapor or spray mist. Wear a dust/mist filtering respirator (MHSA/NIOSH approval number prefix TC-21C), or a NIOSH approved respirator with any N, R, P or HE filter.* Do not get into eyes, on skin or on clothing. *Wear goggles or face shield and rubber gloves and protective clothing when handling. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco.* Remove contaminated clothing and wash clothing before reuse."


2. Since product is sold in one gallon containers, you must revise your storage and disposal instructions accordingly: *Store in original container in a locked storage area inaccessible to children or persons unfamiliar with its proper use. Do not reuse container. Wrap container and discard in the trash.*
