#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC 2125M-P40 Sanitizer Concentrated Powder is designed specifically for use in restaurants, dairies, and bars where sanitization of food contact surfaces is of prime importance.

This product will sanitize previously cleaned and rinsed nonporous food contact surfaces such as tanks, counter tops, drinking glasses and eating utensils. When used at the recommended concentration of 200 ppm no potable water rinse is required.

When used as directed this product is an effective sanitizer against Escherichia coli and Staphylococcus aureus when diluted in water up to 750 ppm hardness (CaCO<sub>3</sub>).

**SANITIZATION** - Remove all gross food particles and soil from areas which are to be sanitized with a good detergent, pre-flush, pre-soak or pre-scrape treatment. Rinse with a potable water rinse. To sanitize pre-cleaned and potable water-rinsed, non-porous, food contact surfaces, prepare a 200 ppm active quaternary solution by using the following dilution table:

To sanitize <u>immobile</u> items such as tanks, chopping blocks and counter tops, apply sufficient product by hand pump trigger sprayer, mop, sponge or cloth to flood the area with a 200 ppm active quaternary solution for at least 60 seconds making sure to wet all surfaces completely. Drain the use solution from the surface and air dry. Prepare a fresh solution daily or more frequently as soil is apparent.

To sanitize <u>mobile</u> items such as drinking glasses and eating utensils, immerse in a 200 ppm active quaternary solution for at least 60 seconds making sure to immerse completely. Remove, drain the use solution from the surface and air dry. Prepare a fresh solution daily or more frequently as soil is apparent.

When used for sanitization of previously cleaned food equipment or food contact items, limit the active quaternary to 200 ppm. NO POTABLE WATER RINSE IS REQUIRED. This product is an effective sanitizer when diluted in water up to 750 ppm hardness (CaCO<sub>a</sub>).

To sanitize <u>previously cleaned food-grade eggs</u> in shell egg and egg product processing plants, spray with a solution of warm water at 200 ppm quat (see Dilution Table above). The solution should be warmer than the eggs, but not to exceed 130°F. Wet eggs thoroughly and allow to drain. Eggs sanitized with this product shall be subjected to a potable water rinse only if they are broken immediately for use in the manufacture of egg products. Eggs should be reasonably dry before casing or breaking. The solution should not be reused for sanitizing eggs.

**PACKETS** - *Tear open packet* - follow label dilution instructions and discard opened packet according to label disposal instructions.

Water soluble packet + follow label instructions by dropping packet directly into water. Do not remove packets before use. Store in a cool dry place. Do not handle packets with wet hands.

TABLETS: Follow label dilution instructions by dropping tablet directly into water. Do not remove tablets from container before use. Store in a cool dry place. Do not handle tablets with wet hands.
