The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide (FIFRA), as amended, is acceptable with conditions.


## **Proposed Amendment**

Update Container Disposal statements to comply with PR Notice 2007-4.

## **Conditions**

Revise the label as follows:

- 1.) The nomenclature for Salmonella choleraesuis must be updated to read "Salmonella enterica" on page 2 (left panel).
- 2.) Revise the Environmental Hazards section on page 3 to be in agreement with the ADBAC RED by adding the following statement, "This pesticide is toxic to fish and aquatic invertebrates."
- 3.) Move the 3<sup>rd</sup> statement under the "Container Disposal" statements for containers 5 gallons or less on page 3 to appear after the statement, "Drain for 10 seconds after the flow begins to drip."

4.) Delete the 5<sup>th</sup> statement under the "Container Disposal" statements for containers greater than 5 gallons on page 3and replace with "Follow Pesticide Disposal instructions for rinsate disposal."

#### FIRST AID

## **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC® 885 Thickened Phosphoric Acid Germicidal Bowl Cleaner is designed to clean, disinfect and deodorize toilet bowls and urinals. When used as directed, this formulation exhibits effective disinfection against Salmonella choleraesuis, Staphylococcus aureus and Pseudomonas aeruginosa in addition to preventing odors caused by microorganisms.

**DISINFECTION** - For gross filth or heavy soil, a pre-cleaning step is required for disinfecting.

To disinfect toilet bowls, flush toilet and direct 4 ounces of this product on to the sides of the bowl and under the rim, letting it run down into the water. Let stand a few minutes, then swab bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

For badly stained toilet bowls, flush toilet and use a toilet mop to push water from the bowl over the trap. Press swab mop against bowl to remove excess water. Direct 4 ounces of this thickened product on to the sides of the bowl and under the rim, letting it run down. Allow sufficient time for product to cover entire surface of bowl for maximum cleaning. Swab bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

To disinfect urinals, flush urinal and direct 4 ounces of this product on to the sides, allowing enough time for complete coverage of the surfaces. Using a scrub brush or toilet mop, scrub urinal surfaces completely. Let stand for 10 minutes and flush.

EFFICACY TESTS HAVE DEMONSTRATED THAT THIS PRODUCT IS AN EFFECTIVE BACTERICIDE IN WATER UP TO 400 PPM HARDNESS (AS CaCO<sub>3</sub>) IN THE PRESENCE OF ORGANIC SOIL (5% BLOOD SERUM).

CORROSIVE. Causes irreversible eye damage and skin burns. Harmful if swallowed or absorbed through skin or inhaled. Do not get in eyes, on skin, or on clothing. Avoid breathing vapor or spray mist. ## STORAGE AND DISPOSAL

#### (Containers 5 gallons or less)

Triple rinse as follows: Fill container ¼ full with water and recap. Agitate vigorously: Follow Pesticide Disposal instructions for rinsate disposal. Drain for 10 seconds after the flow begins to drip. Repeat procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

(Containers greater than 5 gallons):

Triple rinse as follows: Fill container ¼ full with water. Tip container on its side and roll it back and forth, ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into the application equipment or mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

**PESTICIDE DISPOSAL** - Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
