#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC® 885 Neutral Disinfectant Cleaner is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection specifically for hospitals, nursing homes, schools, and other institutions where housekeeping is of prime importance in controlling cross-contamination from treated surfaces.

This product, when used as directed, is formulated to disinfect inanimate hard non porous surfaces such as walls, floors, sink tops, toilet bowls, tables, chairs, telephones, and bed frames. For larger areas such as operating rooms, patient care facilities, and restrooms, this product is designed to provide both general cleaning and disinfecting.

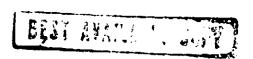
