#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC® 885 Neutral Disinfectant Cleaner-128 is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection for hospitals, nursing homes, hotels, schools, restaurants, and other institutions where housekeeping is of prime importance in controlling cross-contamination from treated surfaces.

This product, when used as directed, is formulated to disinfect hard non-porous inanimate environmental surfaces such as floors, walls, metal surfaces, stainless steel surfaces, porcelain, glazed ceramic tile, plastic surfaces, bathrooms, shower stalls, bathtubs, and cabinets.
