Upon receipt of such an application, we will send your submission into review to determine whether this type of use poses any exposure concerns due to the corrosive nature of your product.

Poultry (And Swine) Premise: Remove all animals and feeds from premises, trucks, cars, coops and crates. Remove all litter, droppings and manure from floors, wails and surfaces of facilities occupied or traversed by animals. Empty all troughs, racks and other feeding end watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Use 1 ounce of (this product or product name) per gallon of water. Saturate surfaces with the recommended disinfecting solution for a period of 10 minutes. Ventilate buildings, coops and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub treated feed racks, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.
