The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with comments:

- . Addition of the public health organism: Human Coronavirus
- . Addition of the non-public health organism: Bovine Viral Diarrhea Virus
- . Addition of the non-public health organism: Xanthomonas axonopodis pv. Citri
- . Addition of tear open (4 and 8 oz) packet directions
- . Expanded use-sites and environmental surfaces
- . Addition of directions for Poultry & Swine Premise Sanitation

EFFICACY

The proposed label claims that the product, BTC 885 Neutral Disinfectant Cleaner-32, is an effective disinfectant against the following microorganisms in the presence of 400 ppm hard water and organic soil (5% serum) at a 1:32 dilution when used for a contact time of 10 minutes: Human coronavirus and Bovine viral diarrhea virus. These claims are supported by your data.

<u>Please Note:</u> Acceptance of the data to support a label claim for Human coronavirus does not in any way support a label claim for the product as an effective disinfectant against the causative agent of Severe Acute Respiratory Syndrome (SARS).

2. Efficacy claims against the non-public health organism Xanthomonas axonopodis pv. Citri (citrus canker) do not require the support of efficacy data. The directions for use of the product to control citrus canker are clear.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

(For labels that list medical premises and metal and/or stainless steel surfaces, one of the following statements must be used:) (This product or product name) is not be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body.

(This product or product name) is not for use on medical device surfaces.

DISINFECTION - To disinfect inanimate, hard non-porous surfaces add 4 ounces of (this product or product name) per gallon of water. Citrus Canker Control: For prevention of Citrus Canker Disease through treatment of equipment. Effective against *Xanthomonas axonopodis* pv. *citri* (Citrus Canker) at 2000 ppm active quat. Treat all trucks, vehicles, and equipment thoroughly at a dilution ratio of 1:13.5 (2000 ppm active quat). Treatment can be applied to trucks, attached trailers, field harvesting equipment; including cargo area, wheels, tires, under carriage, hood, roof, fenders and any other part of transportation equipment that can be taken into infested areas. To prevent the spread of Citrus Canker by this artificial means of transportation, treatments are made by trigger spraying, dipping or brushing, using maximum rate 2000 ppm quat. After use, all surfaces which come in contact with food or crop must be rinsed with potable water.

POULTRY (AND SWINE) PREMISE DISINFECTION

Site Preparation: The first step in any on-going disinfection program should be the removal of gross contamination and debris. This may be accomplished using a shovel, broom, or vacuum depending on the area to be disinfected. The efficacy of even the most efficient germicidal cleaner is reduced in the presence of heavy organic matter. Once the heavy debris is eliminated thoroughly clean all surfaces with soap or detergent and rinse with water.

Cleaning And Disinfection: For all general cleaning and disinfection use 4 ounces of (this product or product name) per gallon of water. Apply (this product or product name) using a cloth, mop, or low pressure coarse sprayer so as to thoroughly wet surface to be disinfected. Allow to remain wet for 10 minutes and then let air dry. For heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution after each use.

APPLICATIONS AND USE DILUTION

Poultry (And Swine) Premise: Remove all animals and feeds from premises, trucks, cars, coops and crates. Remove all litter, droppings and manure from floors, walls and surfaces of facilities occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Use 4 ounces of (this product or product name) per gallon of water. Saturate surfaces with the recommended disinfecting solution for a period of 10 minutes. Ventilate buildings, coops and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub treated feed racks, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse. Immerse all halters, ropes, and other types of equipment used In handling and restraining animals, as well as forks, shovels, and scrapers used for removing litter and manure.

Hatcheries: Use 4 ounces of (this product or product name) per gallon of water to treat the following hard non-porous surfaces: hatchers, setters, trays, racks, carts, sexing tables, delivery trucks and other hard surfaces. Leave all treated surfaces exposed to disinfectant solution wet for 10 minutes or more. Rinse with potable water before reuse. Then allow to air dry.

Vehicles: Clean all vehicles including mats crates, cabs, and wheels with high pressure water and (this product or product name). Use 4 ounces per gallon to treat all vehicles. Leave all treated surfaces exposed to disinfectant solution wet for 10 minutes or more.

Dressing Plant Use: Disinfect equipment, utensils, walls and floors in poultry and animal dressing plants. Disinfect offal rooms, exterior walls and loading platforms of dressing plants.
