BTC® 885 Neutral Disinfectant Cleaner-32 is a phosphate-free, pH neutral formulation designed to provide effective cleaning, deodorizing, and disinfection for hospitals, nursing homes, schools, food processing plants, food service establishments, restaurants, transportation terminals, office buildings, manufacturing facilities, lodging establishments, hotels, retail business, and athletic/recreation facilities, where housekeeping is of prime importance in controlling cross-contamination from treated surfaces.

BTC®885 Neutral Disinfectant Cleaner-32 (this product or product name) for use in:

- Hospitals, nursing homes, medical and dental offices and clinics, operating rooms, isolation wards, and medical research facilities.
- Restaurants and bars, cafeterias, institutional kitchens, fast food operations and food storage areas.
- Supermarkets, convenience stores, retail and wholesale establishments, dressing rooms and laundries.
- · Crime scenes and funeral homes.
- Institutional facilities, laboratories, factories, business and office buildings, restrooms, hotels and motels and transportation terminals.
- Institutional kitchens and bathrooms.
- Institutions, schools and colleges, churches, classrooms, athletic facilities and tocker rooms.

(This product or product name) cleans, shines, deodorizes and disinfects all hard non-porous surfaces listed on the label. It inhibits the growth of mold and mildew, leaving bathrooms and kitchens clean and fresh smelling.

(This product or product name) is recommended for non-scratch cleaning of showers and tubs, shower doors and curtains, fixtures and toilet bowls.

(This product or product name) is for use in institutional kitchens and bathrooms.

### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

(For labels that list medical premises and metal and/or stainless steel surfaces, one of the following statements must be used:) (This product or product name) is not be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body.

(This product or product name) is not for use on critical and semi-critical medical device surfaces.

**DISINFECTION** - To disinfect inanimate, hard non-porous surfaces add 4 ounces of (this product or product name) per gallon of water. Apply solution with a mop, cloth, sponge, hand pump trigger sprayer or low pressure coarse sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes, then remove excess liquid. For sprayer applications, spray 6-8 inches from surface, rub with brush, sponge or cloth. Do not breathe spray mist.

For heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution for each use.

PACKETS (for pre-measured tear open packets) – (Simply) (tear) open and pour contents into (1or 2) gallons of water. Keep packets in box until ready to use.

Pour contents of (4 or 8 oz) packet into (1 or 2) gallons of water. Keep packets in box until ready to use.

To disinfect toilet bowls - Remove gross filth or soils from surfaces with bowl brush. Add 4 ounces of (this product or product name) to the bowl water. Brush or swab the bowl completely using a scrub brush or toilet mop making sure to get under the rim. Let stand for 10 minutes and flush.

Non-Acid Toilet Bowl Disinfection/Cleaner Directions: Remove gross filth prior to disinfection.

To disinfect food processing premises: floors, walls, and storage areas, add 4 ounces of (this product or product name) per gallon of water. For heavily solled areas, a pre-cleaning step is required. Apply solution with a mop, cloth, sponge, hand pump trigger sprayer or low pressure coarse sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes, then remove excess liquid. Hatcheries: Use 4 ounces of (this product or product name) per gallon of water to treat the following hard non-porous surfaces: hatchers, setters, trays, racks, carts, sexing tables, delivery trucks and other hard surfaces. Leave all treated surfaces exposed to disinfectant solution wet for 10 minutes or more. Rinse with potable water before reuse. Then allow to air dry.

Thoroughly scrub all treated feed racks, mangers, troughs, automatic feeders, fountains and waterers with soap or detergent and rinse with potable water before reuse.
