The submitted referenced data (MRID Nos. 440726-01 to 440726-04 and 442237-01 to 442237-02) are acceptable to support effectiveness of these products as a virucide against HIV-2 virus; disinfectant against Streptococcus pyogenes (Clinical-Flesh Eating Strain BIRD M3), Methicillin resistant Staphylococcus aureus, Vancomycin resistant Enterococcus faecalis; and fungicidal against Trichophyton mentagrophytes, Candida albicans and Aspergillus niger when used at 1:32 dilution (4 oz. Per gallon) on hard, non-porous surfaces in the presence of 5% blood serum for a contact time of 10 minutes at room temperature.

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC® 885 Neutral Disinfectant Cleaner-64 is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection for hospitals, nursing homes, hotels, schools, restaurants, and other institutions where housekeeping is of prime importance in controlling cross-contamination from treated surfaces. Authorized by USDA for use in federally inspected meat and poultry processing plants.

This product, when used as directed, is formulated to disinfect hard non-porous inanimate environmental surfaces such as floors, walls, metal surfaces, stainless steel surfaces, porcelain, glazed ceramic tile, plastic surfaces, bathrooms, shower stalls, bathtubs, and cabinets. For larger areas such as operating rooms and patient care facilities, this product is designed to provide both general cleaning and disinfecting.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls, and other areas which are prone to odors caused by microorganisms.

This product is formulated to a neutral pH and will not dull high-gloss floor finishes with repeated use.

DISINFECTION - To disinfect inanimate, hard non porous surfaces add 2 ounces of this product per gallon of water. Apply solution with a mop, cloth, sponge, or hand-pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes, then remove excess liquid.
