



It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BTC® 885 Neutral Disinfectant Cleaner-64 is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection for hospitals, nursing homes, hotels, schools, restaurants, and food processing plants, where housekeeping is of prime importance in controlling cross contamination from treated surfaces.

This product, when used as directed, is formulated to disinfect the following hard, non-porous, inanimate, environmental surfaces: floors, walls, metal surfaces, stainless steel surfaces, glazed porcelain, glazed ceramic tile, plastic surfaces, vanity tops, shower stalls, bathtubs, and cabinets. For larger areas such as operating rooms and patient care facilities, this product is designed to provide both general cleaning and disinfecting.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls and other areas which are prone to odors caused by microorganisms.



Before using this product, food products and packaging materials must be removed from the area or carefully protected. After all surfaces in the area must be thoroughly rinsed with potable water.

To disinfect restaurant food contact surfaces: countertops, appliances, and tables, add 2 ounces of this product per gallon of water. For heavily soiled areas, a pre-cleaning step is required. Apply solution with a cloth, sponge or hand-pump trigger sprayer so as to wet all surfaces thoroughly.
