(THIS PRODUCT OR PRODUCT NAME) IS A FUNGICIDE AT 2 OUNCES PER GALLON (16 MILLILITERS PER LITER) (OR EQUIVALENT USE DILUTION), AGAINST TRICOPHYTON MENTAGROPHYTES MODIFIED IN THE PRESENCE OF 300 PPM HARD WATER AS CaCO₃ AND CANDIDA ALBICANS MODIFIED IN THE PRESENCE OF 400 PPM HARD WATER AS CaCO₃.
