Dear Mr. Issac,

The following amendment submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) as amended, is acceptable with the conditions listed below.

- Change Primary Brand Name
- Addition of microorganisms, use sites, surfaces, claims, and directions
- Amend Basic and alternate formulations 1-5

Conditions

Revise the label as follows:

1. Qualify the surfaces, porcelain tile, granite, and marble, on page 2 as hard nonporous by stating "glazed" porcelain tile, "sealed" granite, and "sealed" marble.

2. Revise the "Disinfection" directions on page 4 by adding the following statements:

All surfaces that come in contact with food must be rinsed with potable water. Do not use on utensils, glasses, and dishes.

3. The last statement under "Fungicidal Activity" on page 5 must be brought into compliance with PR Notice 2001-5, Mandatory Labeling by deleting the term, should, and stating "*must*."

4. Revise the "Personal Protection" statement under the "HIV" directions on page 6 by deleting the term, or, and stating "and.". The use of the listed personal protection equipment is not

5. Revise the first statement under Environmental Hazards on page 10 to be in agreement with the ADBAC and DDAC REDs by stating "This pesticide is toxic to fish, aquatic invertebrates, ovsters, and shrimp,"

6. The container rule no longer separates "Storage and Disposal" by container size; it is distinguished by use pattern such as residential, industrial, institutional, or commercial. Therefore, delete the "Container Disposal" statements for institutional products in containers 1 gallon or less.

7. Revise the "Container Disposal" statements for containers greater than and less than 5 gallons by deleting the triple rinse instructions because it compromises the product's efficacy by pouring rinsate into the application equipment. The Antimicrobials Division is currently working with the Container Rule workgroup to develop appropriate triple instructions. In the interim, all public health use dilution products will use PR Notice 83-3 container disposal instructions by stating "Nonrefillable container. Do not reuse this container. Triple rinse or equivalent."

8. Revise the "Container Disposal" statement for residential products and institutional products by stating "Then offer for recycling or reconditioning. If not available, dispose in a sanitary landfill (or trash for residential containers).

Acceptable Data

Data from EPA Registration No. 1839-215 may be cited to support this product.

General Comments

The primary brand name, SC-NDC-64, is acceptable. The Confidential Statements of Formulas for the basic and alternate formulations 1-5 dated December 19, 2008 is acceptable. They are in compliance with PR Notice 91-2 and in agreement with the label.

A stamped copy of the label accepted with conditions is enclosed. Submit three (3)copies of your final printed label before distributing or selling the product bearing the revised labeling.

Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.

If the above conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
