

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

(For labels that list medical premises and metal and/or stainless steel surfaces, one of the following statements must be used:) (This product or product name) is not to be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. *or*

(This product or product name) is not for use on critical and semi-critical medical device surfaces.

DISINFECTION –To disinfect inanimate, hard non-porous surfaces add 2 ounce of (this product or product name) per gallon of water. To disinfect toilet bowls – Prior to disinfection, remove gross filth or soils from surfaces with bowl brush. Add 1 ounce of (this product or product name) to the bowl water.
