FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

When used as directed (this product)(product name) will inhibit the growth of odor causing bacteria and combat stale water odors and keep drain pans clean preventing condensate pan overflow due to drain line blockage.

Remove inner package from outer plastic bag. Place the package, holes down and tablets facing up, into drain pan at a point as far from the drain hole as possible. Be sure that the single tablet at one end of the package is farthest from the drain hole. In extremely dirty pans it would be helpful to clean the pan before placing the package. The dirt might block the opening in the bottom of the package and inhibit metering of the (product name). Use one package for each 2 square feet of drain pan area.. Replace pouch when tablets have dissolved.
