

DIRECTIONS FOR USE

INDOOR AREAS:

For Brown Dog Ticks: Clean the entire area thoroughly, preferably with a vacuum cleaner. All locations frequented by domestic animals should receive special attention. Clean under furniture, in upholstering of furniture, in corners and along baseboards. Burn or bury all material collected.

For brown dog ticks treat around windows and door frames and also sleeping quarters of household pets. Place fresh bedding in animal quarters following this treatment.

To prevent recontamination, the yard and domestic animals must be decontaminated preferably with TRIANGLE MALATHION DUST or SPRAY. Do not use Triangle Die Roach Spray on pets or other animals.

OUTDOOR AREAS:

Flies, Mosquitoes, Wasps and Flying Moths
Outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

INDOOR AREAS:

For Cockroaches, Ants, Waterbugs, Silver Fish, Spiders, and Crickets: Apply as a coarse spray to all places where insects are hiding or are likely to walk while searching for food, such as baseboards, window and door frames, the underside of shelves, drawers, tables and chairs, under and in back of cupboards, stoves, refrigerators, cracks or holes in walls and around water and drain pipes. Repeat in 2 to 4 weeks in areas where insects are still found. Remove all food and cooking or eating utensils before treatment.

OUTDOOR AREAS:

Fleas, Chiggers, Ants, and Brown Dog Ticks
Outdoors: Spray thoroughly weeds and brushy non-crop areas around the home. For Ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

CAUTION
