velvet bean caterpillar,  
corn earworms, armyworms,  
webworms, stink bugs,  
grasshoppers, blister  
beetles, green cloverworm.

**DISEASES:** Cercospora leaf spot.

Apply 20 to 30 pounds of dust per  
acre by ground duster or airplane.  
Apply when insects first appear or  
when disease spots first appear on  
old leaves at the base of the plant.  
If a heavy rain occurs within 24  
hours after the first application  
repeat in three to seven days;  
otherwise repeat at ten to fourteen  
day intervals.
